Following are the main features of the Scheme:

1. Sons and daughters of parents (Father & Mother both) whose annual income is less than Rs. 8.00 lakhs from all sources shall only be eligible.
2. The waiver is limited to the Tuition Fee only. All other fees except Tuition Fee will have to be paid by the beneficiary student.
3. The eligible candidates have to apply in the given format. The following documents are to be attached along with the Application:
 - a. Declaration by parents regarding income.
 - b. Copies of ITR for the FY 2025-26 for both the parents duly attested by the respective assesses.
 - c. Salary Certificate/Pay slip – self attested (attested by the respective employees) – in case of a parent who is employed.
 - d. Original Certificate of Income issued by Tahsildar/Competent Authority (in case (b) above is not applicable).
 - e. Declaration regarding exemption from Income Tax (duly signed by individual parent in whose case (b) above is not applicable).
